### Objectives

**Overall intended learning outcomes for the course as a whole:**

After completing the module, the student should be able to:

- account for cultural expressions in Sweden, from spatial and temporal perspectives,
- discuss and problematise the concept of Swedish identity,
- compare historical and contemporary cultural expressions in Sweden with examples from other parts of the world,
- conduct a project related to the content of the course.

**Intended learning outcomes for each module**

***Module 1. History and religion in Sweden 7.5 credits***

After completing the module, the student should be able to:

- in general terms account for the main features of Swedish history,
- account for central historical developments, and take into consideration the role and changed status of religions,
- discuss cultural, religious and social conditions in modern Sweden from a historical perspective,
- exemplify and discuss similarities and differences between the historical development in Sweden and the history of some other country or culture.

***Module 2. Music and art in Sweden 7.5 credits***

After completing the module, the student should be able to:

- account for musical and visual means of expression in Sweden from historical and contemporary perspectives,
- identify and describe musical and visual means of expression from different time periods,
- relate musical and visual means of expression to contemporary cultural and societal contexts,
- exemplify and compare musical and visual means of expression in Sweden with the means of expression of another country or culture.

### ***Module 3. The Swedish landscape: temporal and spatial perspectives 7.5 credits***

After completing the module, the student should be able to:

- describe the development and changes in a certain area of the Swedish rural landscape,
- discuss the interplay between humans and the environment from a long-term perspective,
- account for the urban architectural design in different time periods,
- discuss the interplay between urban development and changes in the surrounding rural landscape,
- exemplify and compare the development of the Swedish rural landscape with changes in rural landscapes in other parts of the world.

### ***Module 4. Project, 7.5 credits***

After completing the module, the student should be able to:

- individually or in groups formulate a project idea related to Swedish culture or traditions that may be completed in five weeks of full-time studies,
- collect and evaluate material that may be utilised in the implementation of the chosen project, in consultation with a supervisor,
- analyse, problematise and synthesise material within the chosen field in the cultural sciences, individually or in groups and with the help of a supervisor,
- select an appropriate form (e.g. performance, audiovisual presentation, lecture, poster) for a public presentation, and present the results of the project,
- individually and critically review their collected material in a written paper with correct structure and layout.

## **Content**

The course includes an introduction to and problematisation of various aspects of Swedish culture, identity and traditions.

### ***Module 1 History and religion in Sweden 7.5 credits***

This module introduces the main features of the political, economic, religious and social developments in Sweden during 1,000 years: from the rule of Viking chieftains to the national state and further to a modern, pluralistic country which is part of a more and more globalized world. A sub-theme of the module is the role and changed prerequisites of religions: from the Old Norse religion and Sami tradition, via the predominant role of Christianity, to the present times characterised by secularisation and religious diversity. The concept of Swedish identity is problematised in relation to women and men, the importance of migration, and the expansion of the welfare state. Throughout the module, comparisons and connections are made between Swedish history and the countries and cultures the students are familiar with.

### ***Module 2 Music and art in Sweden 7.5 credits***

This module starts with a general introduction to musical and visual means of expression in Sweden prior to 1720. After this, the module will focus on three time periods:

- the Age of Liberty and the Gustavian period,
- modernity and modernism,
- the present times.

All these will be studied from a combined approach to musical and visual means of expression in various social and cultural environments and institutions. The module will also discuss economic, technical, idea-historical and aesthetic changes. Throughout the module, comparisons and connections are made between musical and visual means of expression in Sweden and in other countries and cultures the students are familiar with.

#### ***Module 3 The Swedish landscape: temporal and spatial perspectives 7.5 credits***

This module discusses the rural landscape in Sweden from archaeological and ethnogeographical perspectives, in particular as regards the development of prehistoric and historical landscapes throughout time, as well as urban architecture and the interplay between the city and changes in the surrounding rural landscape. The interplay between humans, settlements and the environment is also discussed from multidisciplinary and long-term perspectives.

#### ***Module 4 Project 7.5 credits***

In this module, the students apply the knowledge they have acquired in previous modules and conduct an in-depth study, individually or in groups, with the help of a supervisor. The study should be in the form of a project, based on one or more of the fields within the cultural sciences discussed in the previous modules.

In all modules, sessions marked as seminars and workshops in the schedule are compulsory. The excursion in module 3 is also compulsory.

#### **Type of Instruction**

Teaching is delivered in the form of lectures, workshops, seminars, supervision and an excursion.

#### **Examination**

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

In order to receive the grade of Pass, the student must achieve the objectives. Grading criteria for the grade of Pass with Distinction will be specified when the course starts. In order to receive the grade of Pass with Distinction on the course as a whole, the student must have received the grade of Pass with Distinction in three of the four modules.

The following forms of examination occur:

#### **Module 1 is examined through:**

- written assignments
- active participation in seminars

#### **Module 2 is examined through:**

- written assignments
- active participation in seminars

#### **Module 3 is examined through:**

- written assignments
- active participation in seminars and an excursion

#### **Module 4 is examined through:**

- an individual written assignment
- a presentation of the project to others, individually or in groups

For students who do not pass the first examinations, retake examinations are provided in accordance with local regulations at the university.

### Course Evaluation

At the end of the course, a course evaluation is conducted. Results and analysis of the course evaluation are communicated to the students who have taken the course and the students who are taking the course when it is offered the next time. The evaluation is anonymous. The course evaluation is filed according to departmental regulations.
