Förväntade studieresultat

After completion of this course the student should be able to:

- discuss the social and religious circumstances which made possible female exercise of power during the central and late Middle Ages, and also the circumstances which were impediments to this
- discuss important characteristics of female education in the medieval period
- analyse female access to social influence in the medieval period in the context of gender history.

Innehåll

This course unites perspectives from History, Psychology and Education in the analysis of the preconditions of female deployment of power in the Middle Ages. A number of women with power in the political and/or religious spheres are the subjects of case studies. Developments in the fields of politics, religion, justice and education that have facilitated or acted as impediments to female exercise of power are discussed. The course finally discusses how conditions for female exercise of power have developed after the medieval period.

Undervisningsformer

The course consists of web based lectures, seminars and discussions.

Examinationsformer

Kursen bedöms med betygen Underkänd, Godkänd eller Väl godkänd. Examination and grading is based on written assignments and papers. Active participation in seminars and discussions is a precondition for passing of the course.

Re-sits are offered within six weeks (during the semester). The number of re-sits is limited to four.

Course evaluation is carried out at the end of the course. The evaluation is compiled, reviewed with the students and archived according to departmental protocol.
