Prerequisites

Good English language proficiency level, equivalent to level B2/C1 in the Common European Framework of Reference (CEFR).

Objectives

Module 1 English language proficiency 10 credits

Independent project, 8 credits

After completing the module, the student should be able to write clear, well-organized and situation-adapted lengthy academic texts fluently and with a great deal of linguistic certainty.

The student should also be able to correctly use references, cite secondary references and use vocabulary appropriate for the text.

In order to receive the grade of *Pass with Distinction*, the student must also be able to write texts that demonstrate substantial idiomatic, grammatical, structural and stylistic skills.

Oral presentation, 2 credits

After completing the module, the student should be able to deliver oral presentations in a satisfactory manner.

In order to receive the grade of *Pass with Distinction*, the student must also be able to use a varied and idiomatic language in oral presentations.

Module 2. English linguistics, 10 credits

Language structure, 5 credits

In order to receive the grade of Pass, the student should be able to discuss and explain important grammatical terms and concepts as well as be able to use these in basic analyses of authentic English phrases, clauses and sentences. The student should also have an adequate understanding regarding the difference between form and function.

In order to receive the grade of *Pass with Distinction*, the student should, in addition to basic syntactical analysis, be able to apply hierarchical syntactical analysis from the word level to the overall level of clauses in terms of both function and form. The student should also be able to give an account of alternative analyses, when such are possible.

Sociolinguistics, 5 credits

After completing the module, the student should be able to analyze, with the help of linguistic concepts and terms, the linguistic variation in society and in individuals in relation to religion, social identity, power relations, gender, age and ethnicity.

In order to receive the grade of *Pass with Distinction*, the student should also be able to independently plan and conduct a sociolinguistic study within one or more of the areas covered in the course, as well as analyze the results and draw conclusions.

Module 3. English literature, 10 higher education credits

After completing the module, the student should be able to discuss literature as a field of knowledge from a historical perspective and demonstrate knowledge of literary eras, genres and elements of narrative technique.

The student should also be able to analyze literary texts with good knowledge of their social and historical contexts as well as knowledge of certain central literary research traditions and research issues.

In order to receive the grade of *Pass with Distinction*, the student should also be able to demonstrate a very good ability to independently reflect on literary texts regarding both formal aspects and the historical context.

Content

Attendance is mandatory at the course meetings marked as *seminar* on the course schedule.

The course includes the following modules:

Module 1 English language proficiency 10 credits Course objectives

The objectives of this module are to help the students develop their written and spoken English as well as their ability to produce a longer academic text.

Type of Instruction

Independent project, 8 credits

The student chooses a field of study within which an essay will be written, comprising about 10 pages. This will require the student to read literature relevant for the chosen

subject area. Teaching includes process writing with feedback and seminars in small groups, where drafts of the essay will be presented and discussed. The written project will be presented at a final seminar where students act as opponents (critical reviewers) for each other's essays.

Oral presentation, 2 credits

In connection with the writing of the independent project, the students will present their work for the seminar group on several occasions.

Examination

Independent project, 8 credits

Examination and grading for this part of the course is through the written project, acting as opponent for another student's project and defending the student's own project at a final seminar.

Oral presentation, 2 credits

Examination and grading for this part of the course occurs when the student gives a longer oral presentation during one of the classes.

Module 2 English linguistics 10 credits Course objectives

Language structure, 5 credits

The objective of this part of the course is for the students to develop their understanding of the structure of the English language and practice their ability to analyze it using grammatical concepts and linguistic terminology. The student will study a grammar book that has a theoretical emphasis. Great significance is placed on practical analyses and exercises in arguing for and against various solutions. The structure of language as well as its function will be addressed.

Sociolinguistics, 5 credits

The objective of this part of the course is for the students to develop their knowledge regarding the function of language in society in relation to religion, social identity, power relations, gender, age and ethnicity. Literature regarding the role of language in society and sociolinguistic theory will be studied. Comparisons are made between language in English speaking societies and other cultures.

Type of Instruction

Teaching is in the form of lectures and seminars.

Examination

Language structure, 5 credits

Examination and grading is in the form of a written examination.

Sociolinguistics, 5 credits

Examination and grading is based on continual evaluation of active participation and written assignments, as well as short independent field studies.

Module 3 English literature 10 credits

Course objectives

The course objective is for the student to read, analyze and discuss a selection of representative literary texts with emphasis on social and historical contexts as well as the texts' relevance regarding certain literary research traditions and research issues.

English literature: the Middle Ages – 1800, 5 credits

The course covers a selection of literary texts from the the early Middle Ages to the age of Enlightenment.

English literature: 1800 – present, 5 credits

The course covers a selection of literary texts from the Age of Romanticism to the Age of Postmodernism.

Type of Instruction

Teaching is in the form of lectures and seminars.

Examination

Examination and grading for both of these course components is through a written examination.

Type of Instruction

The type of instruction used during the course is described under the section entitled *Content*, above.

Parts of the course may be conducted using ICT-based methods. For specific technical requirements for each part of the course, see the technical requirements on the course's homepage at Lnu.se.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

In order to receive the grade of Pass, the expected learning outcomes must be achieved. The grading criteria for the grade of Pass with Distinction can be found under the section entitled *Expected Learning Outcomes*, above.

In order to receive a final grade of Pass with Distinction for the entire course, the student must receive the grade of Pass with Distinction in at least 20 of the 30 higher education credits as well as receive the grade of Pass with Distinction for the *Independent project*.

The examination forms used during the course are listed under the respective module in the section entitled *Content*, above.

Language proficiency is evaluated during all of the course modules.

Students who do not turn in examination assignments on time will be given the grade of Fail.

For students who fail to earn a Pass grade at the first examination opportunity, a maximum of four additional examination opportunities will be provided.

Course Evaluation

Teaching is continually evaluated throughout the semester.

At the end of the course, a written course evaluation is performed and compiled into a report. The evaluation report is available to students and is filed and stored according to departmental regulations.

Other

Upon request, students who have successfully passed all course requirements may receive a course certificate.
