Prerequisites

Business Administration I, 30 credits or at least 15 credits in Organization and Marketing, or at least 15 credits in Management Accounting.

Objectives

On completion of the course, students should be able to:

- give account for and reflect upon how the processes of organization create and develop organizations
- give account for and reflect upon the subject of organization from a Scandinavian perspective put in relation to internationally recognised concepts

Content

The course content represents different themes based on the literature and current specializations on what is studied within the Scandinavian organization theory. Each theme is introduced and analysed in a lecture processed by the students for the coming seminar.

Type of Instruction

Teaching is in the form of lectures, seminars, case studies and group assignments. Participation in and preparation for seminars is obligatory. Mandatory parts are stated in

the schedule.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

The course is examined through a written exam, reports, oral presentations and active participation in seminars.

Results are graded using one of the terms Passed with distinction, Pass or Fail, and A-F according to the ECTS scale.

For the grade pass, the objectives have to be reached; the grade is based upon the degree to which the objectives are met. The weighing of the grades to the course grade is following the principles in the document "Principer för betygsrapportering dnr ELNU 2011/160".

Students who do not achieve a satisfactory result in the examinations are permitted to make a second attempt approximately 5-8 weeks after the normal examination date. The student will have a minimum of five occasions for written exams in relation to the syllabus to which the student was accepted. Usually 3 occasions per academic year. Students that do not pass reports can complement after consultation with the examiner.

Course Evaluation

A written course evaluation is carried out and compiled in a report, which is archived at the faculty. The results and possible measures taken are communicated by the course coordinator and presented to the students the next time the course is given, or in another way deemed suitable by the course coordinator. Other types of course evaluations, for example regular evaluations throughout the course or discussions with students, will be included and encouraged with the aim of ensuring continuous quality development.
