Objectives

After completing the course, the student should be able to:

- Describe and reflect on hyperlocal journalism, its conditions and structure.
- Independently produce hyperlocal journalistic material and publish this on a digital platform,
- Critically review and evaluate the editorial content from journalistic, hyperlocal and availability perspectives,
- Compare, analyse and present their own and others' material.

Content

This course includes hyperlocal journalistic production, in the form of texts, images and/or other audiovisual material. The student works on a location of their own choice, and publishes their material on social media. The course also discusses perspectives on digital development.

Type of Instruction

Teaching is delivered in the form of lectures, supervision and exercises.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

In order to receive the grade of Pass, the student must achieve the objectives. Grading criteria for the grade of Pass with Distinction will be specified in writing when the course starts.

The course is examined through the submission of editorial journalistic material and written assignments.

- 2301 Hyperlocal journalism: writing (1,5 credits)
- 2302 Hyperlocal journalism: social media (1,5 credits)
- 2303 Hyperlocal journalism: production (1,5 credits)
- 2304 Hyperlocal journalism: analys and reflection (3 hp)
