Prerequisites

Writing and reading literary criticism I, or the equivalent

Expected learning outcomes

After completing the course, students should have:

- improved their ability to write literary criticism,
- deepened their knowledge regarding the history of literary criticism and its function as a cultural-political institution that forms public opinion,
- developed the ability to formulate arguments and write correctly in Swedish.

Content

Module 1: Essayistic (7.5 higher education credits)

The module provides an introduction to the history of essay writing and knowledge about how it manifests itself in contemporary publications, both in the daily press and magazines as well as in book form. As an exercise, the module includes the writing of an essay, the subject and orientation of which is worked out in collaboration with fellow students and the teacher.

Module 2: Writing Book Reviews (7.5 higher education credits)

Students work on practical exercises during which evaluations and stylistic concepts will be discussed and scrutinized. Students will write two book reviews in addition to a self-criticism (a critical assessment of their own critical reviews). In conjunction with all writing exercises in both modules, the course participants must write commentaries on

texts produced by fellow students.

Type of Instruction

Teaching is in the form of lectures and seminars once a month, primarily over the Internet, where course participants will be given the opportunity to internally comment and criticize each other's texts. Attendance is mandatory at the monthly meeting, as well as at every written exercise and commentary session.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

Examination occurs in the form of continual written assignments and active participation during all course components.

A maximum of five examination opportunities will be provided.

In order to receive a final grade of Pass with Distinction for the entire course, the student must receive the grade of Pass with Distinction in both modules.

Students at Linnaeus University are entitled to have the course grade translated into the 7-step ECTS scale. A request to have the grades translated must be made to the teacher at the start of the course.

Course Evaluation

At the end of the course, a written course evaluation is performed and compiled into a report. The evaluation report is available to students and is filed and stored according to departmental regulations.
