## Objectives

On completion of the course, students should be able to:

- describe and apply a systematic custody on the basis of S-ABCDE in connection with taking acutely ill or injured persons into custody
- identify and attend to cardiac arrest on the basis of national guidelines
- identify and apply emergency custody in medical conditions where there is a strong likelihood that alcohol and drugs are involved
- consider ethical and existential needs when taking persons with acute illness or injury into custody

## Content

The following elements are included in the course:

- systematic custody according to S-ABCDE
- prevention of infection and transmission of infection
- taking a person into custody in cases of neck and back injury
- taking a person into custody in cases of blunt and penetrating violence
- taking a person into custody in cases of terminal injuries
- taking a person into custody who is under the influence of alcohol and drugs
- cooperation between police, health care and emergency services when taking ill or injured persons into custody
- CPR
- child CPR
- D-CPR
- fundamental pathology in cases of illnesses that can be associated with the consumption of alcohol or drugs
- ethics

Obligatory elements are specified in the course schedule

### Type of Instruction

- Individual work
- Group work
- Lectures
- Seminars
- Application exercises

The course contains training elements for the development of skills, abilities and attitudes.

### Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

The course is examined with a written examination as well as three clinical examinations. For a grade of Pass, all expected learning outcomes must be fulfilled. For a grade of Pass with credit on the course, students must receive a grade of Pass with credit on the written examination as well as on at least two of the clinical examinations.

A resit examination is offered in accordance with local rules for examination on entry level and advanced level at Linnaeus University (Dnr:2012/129).

Students at Linnaeus University may receive their grades in accordance with the seven-grade ECTS-scale; however, such requests must be made to the teacher at the beginning of the course.

### Course Evaluation

Course evaluations are carried out at the end of every course. Course evaluations are compiled and the results are fed back to the students by the course co-ordinator. The compilation is archived.
