Prerequisites

General entry requirements and English B (Field-specific entry requirements 2/A2). 1MU134 Today's Music Business. All courses 1–60 credits in the Songwriting Programme completed.

Objectives

After completing the course, the student should be able to:

- identify the parts of the legal system and relevant sources of law, and discuss how these are used,
- identify juridical concepts, legal principles and central regulations in contract law, company law, intellectual property (copyright, trademark law, design right), and market right, and discuss how these are applied on the basis of the specific conditions and interests of the music business,
- define juridical issues and discuss and apply juridical methods to solve them.

Content

This course includes an introduction to legal contexts, methods and tools. For example, the course discusses intellectual property, market right, company law and contract law, both from a general perspective and from the perspective of the music business. The course also discusses Swedish juridical regulations and relevant international conventions and EU sources, as well as legal cases concerning music law.

Type of Instruction

Teaching is delivered in the form of lectures, practical applications, literature studies, thematic/project-based studies and seminars.

Examination

The course is assessed with the grades A, B, C, D, E, Fx or F.

The course is examined through written examinations.

The grade A is the highest grade and the grade E is the lowest grade for passing the course. The grade F means that the student's performance is assessed as failed. For students who do not pass their first examinations, retake examinations are provided in accordance with Local regulations for courses and examinations at the first and second levels at Linnaeus University.

If the university has decided that a student has the right to special educational support due to a disability, the examiner may offer an adapted test or allow the student to conduct the test in an alternative form.

Course Evaluation

At the end of the course, a course evaluation is conducted. Results and analysis of the course evaluation are communicated to the students who have taken the course. Students who are taking the course when it is offered the next time are informed of the results at the start of the course. The evaluation is anonymous.
