Prerequisites

Survey to Commercial Law, 15 higher education credits and Administrative Law including the examination and documentation of matters, 15 higher education credits

Expected learning outcomes

To pass the examination, the student must

- show deeper understanding of the different kinds of legal relations existing between the individual and the general public
- be able to identify and analyse administrative law problems and be able to provide well substantiated and justified solutions to the problems
- have the ability to independently investigate and account for administrative law issues
- have the ability to place administrative law issues in a greater societal context
- show knowledge of the connections between national regulations in administrative law and the European convention protecting human rights and the basic freedoms
- show knowledge of the operations of various supervisory authorities

Content

The aim of the course is to give the students deeper knowledge of general and specialized administrative law acquired during the course administrative law with supervision and documentation. Furthermore, the course will convey knowledge of both material and procedural regulations concerning certain selected areas of specialized administrative law and the European convention.

Type of Instruction

Teaching consists of lectures, seminars, and individual assignments with some supervision. The students' own preparations and activities will form the basis of the learning process.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

Assessment will take place by means of oral and written accounts of written assignments, plus a written exam.

A retest will be offered a few weeks after the original test for students who have not successfully passed the original test. At least 5 tests will be offered.

The grades are Pass with Distinction (80%-100%), Pass (60%-79%) or Failure (0%-59%).

Students at Linnaeus University are entitled to have the course grade translated into the 7-step ECTS scale. A request to have the grades translated must be made to the teacher at the start of the course.

Course Evaluation

A written course evaluation is performed and compiled into a report to be kept in the university school archives. The result and any measures taken are communicated to the course co-ordinator and presented to the students participating the next time the course is offered.

Other

Students at Linnæus University can, at request, receive their grades in ECTS credits, according to the ECTS-scale. This request should be made in connection to the introduction of the course.
