Prerequisites

General entry requirements Logistics 7.5 credits or equivalent

Objectives

The aim of the course is to provide students with good knowledge of the legal problems that can occur for buyers and sellers of products and for producers of transport and logistic services. On completion of the course, students should be able to:

- Identify legal problems and apply legal methods for solving legal problems within transport and logistic law
- Find and analyse legal material within Swedish transport and logistic law
- Explain and investigate responsibility distribution during damage in connection with transport and logistic missions
- Determine when legal expertise should be consulted

Content

The course begins with a fundamental run-through of the Swedish legal system. After this, the course continues with a general run-through of Swedish property law such as contract law, purchase law and tort law. Emphasis is placed on risk transfers within commercial trade, and Incoterms. Also included here is a general run-through of international commercial contract law and purchase law as well as different forms of payment. Furthermore, elements of transport law, where the different rules of transport law (sea, road, rail as well as air) are discussed, and logistic law, where middleman law and the branches standard agreement NSAB 200 are discussed, are included. The

course also contains a run-through of the different current forms of insurance. What is more, future logistics (what problems it can cause for law) is discussed.

Type of Instruction

Teaching is in the form of lectures and seminars.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

The course is examined through individual written examinations and through papers written in groups, as specified in course instructions. Examination also include oral presentation in a professional manner. Active participation in mandatory seminars is required for a pass grade.

Students who do not achieve a satisfactory result in the examinations are permitted to make a second attempt approximately 5-8 weeks after the normal examination date. The student will have a minimum of five occasions for written exams in relation to the syllabus to which the student was accepted. Usually 3 occasions per academic year.

For the grade pass, the expected learning outcomes have to be reached; the grade is based upon the degree to which the learning outcomes are met. The weighing of the grades to the course grade is following the principles in the document "Principer för betygsrapportering dnr 2011/160".

Course Evaluation

A written evaluation is conducted and compiled in a report, which is filed at the department. The result and actions, if taken, are presented to the students in the way most appropriate according to the teacher responsible for the course. Other types of evaluations, such as continuous during the course or oral communication with the students, can occur and is encouraged to secure continuous quality improvement.
