Objectives

After completing this course the student should be able to:

- implement information searches and thereby find relevant legal sources in the areas of labour law
- read and interpret labour law texts, preparatory work and legal cases
- conduct and present (orally and in writing) a legal investigation regarding labour law issues and/or situations
- to analyse and problematise labour law issues
- apply labour law rules and principles and present arguments for proposed solutions to problems based on legal methodology

Content

The course includes an introduction about the legal system, legal sources and legal methodology with a special focus on working life. An important part of the course is the interaction between labour law legislation and the regulation of collective bargaining. Furthermore, general legal principles regarding relationships between the

employer and the employee are discussed repeatedly during the course. Central national legislation on, e.g., employment protection, the right of association and the right of negotiation, industrial action, discrimination, work environment, working hours and leave is discussed. Some of these areas highlight an EU legal perspective and differences in labour law between the private and public sectors.

Type of Instruction

The teaching consists of lectures, practice exercises and a group project.

Examination

The course is assessed with the grades A, B, C, D, E, Fx or F.

The course is examined through a written assignment and a written exam.

The grade A constitutes the highest grade on the scale and the remaining grades follow in descending order where the grade E is the lowest grade on the scale that will result in a pass. The grade F means that the student's performance is assessed as fail. Grading criteria for the A–F scale are communicated in writing to the student by the start of the course at the latest, as well as how the weighting and weighting of grades on individual examining elements to the final course grade takes place. The basis for the student's grade is determined by the student's fulfillment of the objectives.

Repeat examination is offered in accordance with Local regulations for courses and examination at the first and second-cycle level at Linnaeus University. An examiner can, in exceptional cases, decide that a student who is close to the level for a passing grade may carry out supplementary assignments in order to reach the passing grade.

If the university has decided that a student is entitled to special pedagogical support due to a disability, the examiner has the right to give a customised exam or to have the student conduct the exam in an alternative way.

Course Evaluation

During the implementation of the course or in close conjunction with the course, a course evaluation is to be carried out. Results and analysis of the course evaluation are to be promptly presented as feedback to the students who have completed the course. Students who participate during the next course instance receive feedback at the start of the course. The course evaluation is to be carried out anonymously.
