### **Prerequisites**

In order to be admitted to the course students have to have passed 105 credits out of 120, of the basic two years on the Business Administration and Economics Programme, and to have participated in 30 credits within the specialization on the Business Administration and Economics Programme, including Research Methodology in Business Administration, 7.5 credits.

## Objectives

After completing the course the student is expected to be able to:

- independently identify and formulate limited, theoretical and empirical relevant, research problems
- use scientific research methods
- collect and analyse data
- critically discuss research
- independently write and present a independent subject project

## Content

The course includes a series of seminars. The independent subject project includes definition and formulation of problems , writing a report and critically discuss other

student's independent subject works .

### **Type of Instruction**

The teaching consists of seminars and tutoring. Obligatory parts are stated in the schedule.

### **Examination**

The course is assessed with the grades A, B, C, D, E, Fx or F.

The degree project consists of a written report that will be defended during a seminar. Students are also required to act as opponent on another degree project as part of the examination.

The grade A constitutes the highest grade on the scale and the remaining grades follow in descending order where the grade E is the lowest grade on the scale that will result in a pass. The grade F means that the student's performance is assessed as fail.

Grading criteria for the A–F scale are communicated in writing to the student by the start of the course/module at the latest, as well as how grades on separate elements of examination are weighed to a final course grade.

A degree project that is not assessed to possibly fulfill the requirements at the final tutoring is recommended not to be treated at the originally scheduled final seminar.

### **Course Evaluation**

A written course evaluation is carried out and compiled in a report, which is archived at the faculty. The results and possible measures taken are communicated by the course coordinator and presented to the students the next time the course is given, or in another way deemed suitable by the course coordinator. Other types of course evaluations, for example regular evaluations throughout the course or discussions with students, will be included and encouraged with the aim of ensuring continuous quality development.

### **Credit Overlap**

The course cannot be included in a degree along with the following course/courses of which the content fully, or partly, corresponds to the content of this course: The course overlaps 2FE01E and 2FE28E:3 with 15 credits each.
