### **Objectives**

After completing the course, students shall be able to:

- account for and compare the role of leadership within the police organisation in view of the following perspectives; strategic, indirect level and direct level
- in general terms, describe the police organisation and present its governance and the relation between core values, policy model and management plan
- implement the police mission in practice by applying established guidelines and legislation relevant to the police activities
- use clear verbal communication for individual feedback, as a tool for developing self-knowledge and a self-image that correlates with other people's image
- present an idea of operation in accordance with established national guidelines and based on a presented situation
- implement in practice tactical methods at work in groups.

## Content

The course provides advanced knowledge of the police as an organisation, its management and governance, and during lectures held students get to meet managers at the strategic, indirect and the direct levels. Students learn about the police values and leadership based on a perspective of understanding, as a tool used within management/leadership. Students are also trained in using the tactical methods in a flexible manner as well as in groups. Methods are theoretically practiced as well as in practice in various environments. Compulsory elements in the course; tactical methods applied during a day of exercise.

In order to increase the awareness of the self-image that individuals have in relation to other people's opinions, interviews are held with people in the surrounding environment. The emphasis is placed on the aspects of giving and taking as well as growing through feedback.

Students complete a practical exercise during the course, in PTÖ - exercise in police tactical approach. This exercise is focused on everyday events and the police duties that such events involve, from alarms to debriefing. The exercise is integrated with knowledge and skills acquired through the previous courses within the police education.

## Type of Instruction

Knowledge acquisition takes place through individual work, base group work, seminars, lectures and practical application. Students are expected to take an active part in discussions held during lectures and seminars.

## Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

Examination of the course takes place by means of an individual paper, an applied exercise and a seminar.

During the applied exercise, students will be assessed and receive feedback based on a number of criteria, for instance within law. This exercise is also used as the basis of a following discussion and examination seminar, including self-evaluation of their own actions and reactions following the completed exercise in police tactical approach, PTÖ.

In order to receive a grade of Pass, the intended learning outcomes must be attained.

To be awarded a final grade of Pass with Distinction in the course, it is required that the individual paper is assessed as Pass with Distinction.

## Course Evaluation

A course evaluation is carried out either during or at the end of the course. Results and analysis of the evaluation are presented to the students who have completed the course, as well as to the students at the following course date. The course evaluation is conducted anonymously. The results are reported to the programme council and filed by the Institute of Police Education.
