On completion of the course, students should be able to:

Knowledge and Understanding

- formulate questions and reflect over the connection between agents, transmission routes and resistance development
- formulate questions and reflect over the role of the immune system during infections
- formulate assumptions concerning the importance of different factors for the prevention of disease
- assess risks for the spreading of infection as well as relate to hygienic and aseptic principles on different levels
- understand and account for common infectious diseases' etiology and pathophysiology
- understand and account for medical measures against certain infectious diseases
- identify and formulate questions concerning specific nursing measures against infectious diseases
- relate to relevant laws and regulations

Skills and Abilities

- identify and account for specific nursing and medical care of infectious diseases

Judgment and Approach

- understand and meet different cultural needs within infection care
- critically examine society's efforts within infection care

Content

The course consists of three modules:

Module 1 7.5 credits

- Clinical microbiology
- Immunology
- Transmission routes
- Care hygiene

Module 2 15 credits

- Epidemiology
- Etiology, clinic and therapy for certain infectious diseases
- Specific nursing within infection care
- Infectious diseases in an international perspective
- Needs of various cultures
- Evidence-based care and nursing
- Laws and regulations

Module 3 7.5 credits

- Independent work

Type of Instruction

The course is net-based, no physical meetings are included. Study assignments are carried out under supervision, individually or as part of a group, and are discussed in web-based discussion forums. Obligatory attendance is expected throughout the entire course, or parts of it, and this is specified in schedules and study guidelines.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

Course Evaluation

A written evaluation is carried out and compiled in a report, which is archived at the institution. The results, along with possible measures taken, are reported to the students the next time the course is given.
