Prerequisites

1-90 higher education credits in Swedish for teacher education or 1-90 higher education credits in Comparative literature

Expected learning outcomes

After completing the course, students should:

- have developed a deeper analytical ability based on scientific grounds in relation to contemporary literature, where fact and fiction meet in the same text,
- be able to explain and discuss the development of the history of popular literature as well as its typical characteristics based on different theoretic and methodological perspectives,
- independently and in a group, have appreciably developed the ability to identify and critically interpret the perception of reality that can be ascribed to fiction literature's documentary or fictitious level.

Content

The course deals with literature with claims to be true (documentary novels, autobiographies/autobiographical novels, etc.) and how, within schools' teaching environments, we create critical readers of these "truths". The course also allows for reflection on the emphasis and balance between popular literature and classics in Swedish language education.

Type of Instruction

The course is based on the students' active participation. Teaching is in the form of

lectures, seminars in conjunction with assignments or literature.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

Examination occurs in the form of a report that deals with the course literature and where students discuss and analyze didactic questions, if possible, in relation to their own experiences. The reports will be publicly discussed during mandatory seminars.

A maximum of five examination opportunities will be provided.

Students at Linnaeus University are entitled to have the course grade translated into the 7-step ECTS scale. A request to have the grades translated must be made to the teacher at the start of the course.

Course Evaluation

At the end of the course, a written course evaluation is performed and compiled into a report. The evaluation report is available to students and is filed and stored according to departmental regulations.
