Prerequisites

90 credits including an independent project of 15 credits in the humanities or the social sciences or the equivalent, and English B/English 6 or the equivalent.

Objectives

After completing the course, the student should be able to:

- in speech and writing discuss the applicability of postcolonial theories in comparative literature,
- compare and discuss important research in texts and fiction within the field of postcolonial studies,
- account for how historical processes and literary developments have shaped the field of postcolonial studies,
- apply central theoretical concepts in analyses of literary texts.

Content

The course advances the student's knowledge about the use of postcolonial theory in literary studies from a historical perspective, as well as about the relevance of postcolonial theory for fiction and the development of fiction.

Type of Instruction

Teaching is delivered in the form of lectures, seminars, and group discussions.

Examination

The course is assessed with the grades A, B, C, D, E, Fx or F.

The grade A constitutes the highest grade on the scale and the remaining grades follow in descending order where the grade E is the lowest passing grade. The grade F means

that the student's performance is assessed as fail. Grading criteria for the A-F scale are communicated to the student in a separate document. The student is to be informed about the grading criteria at the start of the course at the latest.

The course is examined through written assignments and oral seminar presentations. Reexamination is conducted in the form of a written assignment or another assignment decided by the examiner. If the university has decided that a student is entitled to special pedagogical support due to a disability, the examiner has the right to give a customised exam or to have the student conduct the exam in an alternative way.

Course Evaluation

During or shortly after the course, a course evaluation is conducted. Results and analysis of the course evaluation are promptly communicated to the students who have taken the course. Students who are taking the course when it is offered the next time are informed of the results at the start of the course. The evaluation is anonymous.
