Prerequisites

90 credits including an independent project of 15 credits in the humanities or the social sciences or the equivalent, and English 6 or the equivalent.

Objectives

After completing the course, the student should be able to:

- account for how colonialism and postcolonialism relate to different historical processes and literary developments in a Nordic context,
- account for the concept "postcolonial", and apply it to Nordic literature in analyses of literary texts,
- reflect critically on political, epistemological and moral aspects of postcolonial discussion in a Nordic context.

Content

The course deepens students' knowledge about the use of postcolonial theory in a Nordic context, as applied to Nordic literature.

Type of Instruction

Teaching is delivered in the form of lectures, seminars, and group discussions.

When the course is offered as a distance course, ICTbased teaching forms will be used. For specific technical requirements, see the course website.

Examination

The course is assessed with the grades A, B, C, D, E, Fx or F.

The grade A constitutes the highest grade on the scale and the remaining grades follow in descending order where the grade E is the lowest passing grade. The grade F means that the student's performance is assessed as fail. Grading criteria for the A–F scale are communicated to the student in a separate document. The student is to be informed about the grading criteria at the course start at the latest.

The course is examined through written assignments nd oral seminar presentations. Reexamination is provided in the form of a written assignment or other assignment decided by the examiner. If the university has decided that a student is entitled to special pedagogical support due to a disability, the examiner has the right to give a customised exam or to have the student conduct the exam in an alternative way.

Course Evaluation

During or shortly after the course, a course evaluation is conducted. Results and analysis of the course evaluation are promptly communicated to the students who have taken the course. Students who are taking the course when it is offered the next time are informed of the results at the start of the course. The evaluation is anonymous.
