Prerequisites

General entry requirements for second-cycle studies and specific entry requirements: 90 credits within the main field of study Education, or equivalent main field of study including an independent project comprising at least 15 credits, or a Bachelor or Master of Arts in Education, including a degree project. Swedish B and English A, or the equivalent.

Objectives

Upon completion of the course, students shall be able to:

- account for and demonstrate advanced knowledge of the disciplinary foundation

as it is reflected in empirical research and theories within the specialisation of general education, working life and adult learning, didactics and learning, teachers' practice, special education or social pedagogy,

- on the basis of the chosen specialisation, conduct a fundamental discussion on the relation between theory and empiricism and the relation to best practice.

Content

Students shall learn how to find and compile relevant international research material in databases and how to analyse and assess the relevance of the research with reference to theories and methods. The relation between theory, empiricism and best practice is also looked into.

Type of Instruction

Teaching takes place in the form of lectures and seminars.

Examination

The course is assessed with the grades Fail (U), Pass (G) or Pass with Distinction (VG).

Examination of the course objectives takes place by means of two oral presentations in seminars, and a written assignment.

In order to receive a grade of Pass in the course, the course objectives must be attained. For a grade of Pass with Distinction in the course, the written assignment requires the grade of Pass with Distinction.

A retake of the examination is provided in accordance with the Local Regulations for First-Cycle and Second-Cycle Courses and Examination at Linnaeus University.

Should the university determine that a student is entitled to special educational support due to impairment, the examiner may provide the student with an adapted test or the student may carry out the examination in an alternative way.

Course Evaluation

A course evaluation is carried out either during or at the end of the course. Results and analysis of the evaluation are presented to the students who have completed the course as well as to new students at the following course date. The course evaluation is conducted anonymously.
