# Description of Programme

The aim of the Social Work Study Programme is to educate qualified social workers as well as prepare them for further study. Social work forms the principal field and is based on knowledge and understanding of the interplay between people, the surrounding community and social interventions.

The Social Work Study Programme provides training in professional competence for the social welfare sector, under public, private and non-profit management, nationally and internationally. Social workers work with preventive social work, treatment, work with social change, case management, evaluation and development of social operations — often in collaboration with other organisations and professions. Personnel management and organisation of social operations are other tasks for social workers. Common working areas include social services, health and medical care, schools, treatment centres, social care work with older people and people with disabilities, treatment of offenders, social insurance, employment offices, migration agencies and other government authorities.

The Social Work Study Programme provides preparation for studies at second-cycle level

# Objectives

#### Qualitative Targets in accordance with the Higher Education Ordinance

In order to obtain a Bachelor of Science in Social Work, the student shall have acquired the knowledge and practical skills required for social work at the individual, group and societal level.

#### Knowledge and Understanding

For the Bachelor of Science in Social Work, the student shall:

- demonstrate knowledge of the disciplinary foundation and current research and development work within the field;
- demonstrate knowledge and understanding of the interplay between individuals' and groups' social situations, living conditions, physical and mental health as well as the ability to function in relation to social and other underlying factors;
- · demonstrate knowledge of leadership within social work;
- demonstrate knowledge and understanding of a child's needs as well as social conditions and family circumstances that affect the living conditions of both men and women

## Competence and Skills

For the Bachelor of Science in Social Work, the student shall:

- demonstrate the competence and skills required to develop and conduct social work at different levels of society, cooperating with those people affected;
- demonstrate the ability to apply the relevant legislation within the social area in particular;
- demonstrate the ability to understand, investigate and analyse social processes and problems;
- demonstrate the ability to identify, structure, investigate and evaluate actions at the individual, group and social level.

## Judgement and Approach

For the Bachelor of Science in Social Work, the student shall:

- · demonstrate self-awareness and empathetic ability;
- demonstrate the ability to conduct operational assessments with an overall view
  of the individual and based upon the relevant scientific, social and ethical aspects,
  paying particular attention to human rights:
- demonstrate the ability to adopt a professional approach and attitude;
- demonstrate an insight into the importance of team work and cooperation with other professions;
- demonstrate the ability to identify the personal need for further knowledge and to develop the individual competence.

# Programme Specific Objectives

In addition to the above-stated outcomes, the Social Work Study Programme at Linnaeus University has the following programme-specific objectives. Upon completion of the programme, the student shall:

- demonstrate the ability to integrate knowledge of human rights, social rights and anti-discrimination into social work;
- demonstrate knowledge and the ability to critically analyse the professional conditions and development of social work, from a national and international perspective.

#### Content

The Social Work Study Programme is part of the Faculty of Social Sciences.

#### Programme overview

The programme builds upon a theoretical understanding of a person's circumstances and the origin of social problems, and interventions within social work. The programme further provides knowledge of the important legislation for practical social work. The Social Work Study Programme provides skills for investigating social needs and issues, evaluating social interventions and integrating theory-based knowledge into practical social work. Individual specialisation takes place via elective courses. Professional development permeates the entire programme. Specific components such as supervision and reflection groups aim to develop the student's abilities for a professional approach, empathy and cooperation. The programme includes field studies and work placement training worth 30 credits. The courses in the programme are studied in the order as follows.

# **Programme Courses**

\*= course within the main field of study

#### Semester 1

Social Work as Subject, Science and Profession, 15 credits, G1N\*
Welfare State Organisation and Principles of Social Policy, 15 credits, G1N\*

The programme begins with a basic course in social work as a subject, science and profession. The course contains theories from the social sciences and humanities, concepts from the theory of science, ethics and professional approach. After this, the organisation and central socio-political principles of the welfare state are studied. The course explores the growth and structure of the Swedish welfare system and its organisation and function in Swedish society.

#### Semester 2

Introduction to the Legal System and Social Law, 15 credits, G1N Social and Behavioural Science Perspectives in Social Work, 15 credits, G1N\*

The first course in semester 2 focuses on the relevant laws for the main area of social work. The course provides an introduction to the legal system and knowledge of civil and criminal law, social law and international conventions on human rights. The second course studies sociological, socio-psychological and psychological theory formulation important to social work.

#### Semester 3

Communication, Approach and Management, 15 credits, G1N\* Administrative Law and Investigative Methodology, 15 credits, G1F

Semester 3 studies and practises interview skills, communication and attitudes in relation to people and groups with specific needs, from both a user and leader perspective. The course includes information about leadership of individual operations and at different levels of social work. The second course of semester 3 examines law, focusing on administrative law as well as case management and investigation methods.

#### Semester 4

Vulnerability, Conditions and Interventions at Individual, Group and Society Level, 15 credits, G2F\*

Writing a Dissertation, 7.5 credits, G2F\* Evaluation in Social Work, 7.5 credits, G2F\* At the start of the fourth semester, deeper knowledge will be obtained regarding people's vulnerability and mutual and specific living conditions. Moreover, the course focuses on the knowledge of preventive social work, working methods and interventions in social work at the individual, group and social level. The second course practises academic writing skills for a paper/project area focusing upon vulnerability and social interventions. Semester 4 concludes with a course about models for scrutinising and evaluating social interventions, in addition to studies about what knowledge-based social work entails.

Semester 5

Social Work Training in the Social Sector, 30 credits, G2F\*

The student placement training (VFU) takes place in semester 5. During the teaching period, the social practice is scrutinised and problematised based on theoretical knowledge and skills under supervision. The course contains components where the aim is to develop a reflective approach and professional identity. It is possible to spend the entire or part of the semester studying abroad.

Semester 6

Research in Social Work, Theory of Science and Research Methodology, 15 credits, G2F\*

Degree Project, 15 credits, G2E\*

Semester 6 expands upon knowledge of research and development within social work. The first course provides the students with current research and deepens their knowledge within the theory of science and research methodology. The second course applies methodological skills, analytical ability and aspects of research ethics to an independent project/degree project.

Semester 7

Elective Advanced Course in Social Work, 15 credits, A1N\* Professional Social Work, 15 credits, A1N\*

Semester 7 begins with an elective specialisation course at advanced level. The department offers elective courses within specialised areas relevant to social work and related to current research within the field. The courses available reflect the research domains of the department. Students may also choose to study a course in social work at advanced level at another university. The elective courses offered at Linnaeus University may change from semester to semester and can be studied at campus in Kalmar or Växjö.

The second course provides advanced knowledge of professional social work, focusing on professionalisation processes and the specific competence of social workers in relation to evaluations and interventions from the perspective of knowledge-based social work. The course also studies the cooperation with other professions. It is possible to study the entire or part of the semester abroad.

The above-stated courses in the Social Work Study Programme are compulsory for the Degree of Bachelor of Science in Social Work unless otherwise stated above, as is the possibility to study abroad or elective courses. The order of the courses given may change, and some courses may be held in English.

#### Societal Relevance

The Social Work Study Programme cooperates with care user organisations, government authorities and activities that conduct and develop social work within social welfare, at the local as well as at the national level. Semester five includes student placement training within social work, with professional supervisors. Field studies at workplaces relevant to social work are regularly conducted in the programme. Care user representatives and representatives from different activities participate in the programme on a regular basis.

Students are offered information about future career opportunities and the possibility to participate in voluntary or paid social work within the region.

#### Internationalisation

The programme prepares the students for work in a society characterised by diversity and globalisation. In several of the courses, students will meet internationally successful teachers/researchers as well as students from other countries. The programme also discusses issues on globalisation, migration and diversity.

The Social Work Study Programme is part of several international networks, entailing active international exchanges for both teachers and students. Students are during the programme given the opportunity to study or conduct their student placement training abroad, preferably in semester 5. Courses may be studied at a higher education institution abroad, provided that they correspond with the ones to be studied in accordance with the programme syllabus. Students are offered the opportunity to take part in the exhange agreeements that Linnaeus University has with foreign higher education institutions, and this takes place primarily from semester four within the programme. Studies abroad shall always be planned in consultation with the internationalisation coordinator at the department.

## Programme Perspectives

Sustainable Development

The Social Work Study Programme rests upon national and international ethical principles of human rights, the concept of human dignity and social justice as a basis of the development of a socially sustainable society. The programme addresses the concept of sustainable development on the basis of the social, environmental and economic perspectives in a global context, relevant to people's living conditions and conditions of survival as well as good and equal living conditions over time.

It comes down to the aim of turning out sustainable students, and sustainability in relation to the profession, which is central for the programme. This may for instance include teaching and methodology practice in individual professional development.

#### Equal Terms

Within the Social Work Study Programme, work is conducted within the field of equal rights and equal opportunities with the aim of promoting equal terms and equality. The diversity perspective is thus central through the entire programme, and the focus is placed on establishing a long-term sustainable social development. Teaching is based on actively counteracting discrimination and has an ethical perspective.

Broadened Knowledge Perspective

The Social Work Study Programme is a generalist education which requires a breadth in terms of subjects as well as in relation to multifaceted and extensive fields of work. Social work is an interdisciplinary subject and the aim of the programme is for students to develop a critical and ethical approach in a field where also the integration of other subjects takes place. This takes place through complementary studies within other areas of knowledge, and by reading fiction as well as by having critical discussions and conversations in seminars. The studies are based on a combination of theory and practice, and a close connection between the student placement training and the social work practice.

## Entrepreneurial Approach

Students reflect on how an entrepreneurial approach may affect and develop the existence of social work. This theme is also addressed through interaction with the society in order to establish more concrete support and to stimulate the development of the students' general competencies, such as communication and cooperation. Interaction may also lead to increased commitment to the surrounding society and the existing processes outside the university. Parts of the programme are further characterised by entreprenurial learning, since various educational forms are aimed at developing the students' curiosity, responsibility and self-reliance.

# Quality Development

The board of the Faculty of Social Sciences holds the overall responsibility for the quality of the education and the systematic quality assurance in terms of follow-up of the programme as a whole and the progression of the studies, and shall develop the relevance to people representing outside interests and the relation to current research. The programme assures student participation and leverage through systematic implementation of written evaluations of each course and the programme, and through student representation in the faculty board, working committee and student representative forums. The students' views are used as a basis for the board's quality assurance. Compilations of various evaluations are accessible through the university

# Degree Certificate

After completed studies in accordance with the objectives specified in the Higher Education Ordinance's system of qualifications and Linnaeus University's system of qualifications, the student can apply for a diploma. Those having completed the Social Work Study Programme can obtain the following qualification:

Bachelor of Science in Social Work

The degree certificate is written in Swedish and English. The diploma also comes with a Diploma supplement (in English).

# Other Information

Students who complete six terms of the Social Work Study Programme (180 credits) may apply for a Bachelor of Science (main field of study: Social Work).
